INTRODUCTION

AMIS is an interdisciplinary centre for migration research based at the Faculty of Humanities at the University of Copenhagen. Since its establishment 2013 the research center has entered its consolidation phase with a strengthened research focus on qualitative and ethnographic approaches to the study of moving populations and mobility practices as well as irregularized and forced migration.

The primary aims of AMIS include:

- promoting excellent research within social sciences and humanities approaches to migration
- stimulating and facilitating cooperation among researchers at the Faculty of Humanities engaging in the study of migration
- providing a forum in which research projects and papers can be developed, discussed, and improved
- stimulating national and international research cooperation on migration, and hosting talks, conferences, roundtables, and book-launches
- addressing issues of migration for which there is significant societal interest
- further developing the master's degree programme in advanced migration studies.

Highlights 2021

- From 2019-2021 AMIS has attracted a total amount of DKK 7.716.532 external research funding. In 2021 the external funding amounted to DKK 446.715, which testifies that the funding years will likely fluctuate from year to year.
- AMIS researchers have published 31 titles including research articles, book chapters, and edited volumes (please see overview below).
- AMIS organized the online seminar on Danish Externalisation Policies

AMIS organization

Since 2019 Associate professor Marie Sandberg (SAXO) is Head of centre, supported by centre coordinator Maria Frantzoulis and the AMIS steering group: representing each of the departments of the Faculty of Humanities: Margit Warburg (ToRS), Anders Michelsen (IKK), Martha Sif Karrebæk (NORS), Trine Øland (MEF), Georg Wink (EnGeRom). Due to her retirement Margit Warburg will be replaced by Andreas Bandak (ToRs) starting from 2022 onwards.

Margit Warburg's contribution to AMIS has been invaluable and we regret her stepping back. We are very happy to welcome Andreas Bandak in her place.

During E2021 Associate Prof. Simon Turner was acting director of AMIS while Marie Sandberg was on research leave as visiting Associate Professor at the Research Excellence initiative: Center for Migration Studies, University of British Columbia, Canada.

AMIS people

During the year of 2021 the AMIS staff group consisted of 11 members including 2 visiting postdocs, 1 guest PhD student, 1 external lecturer.

- Associate prof. Zachary Whyte was recruited after an open call for a parttime Associate Professorship, starting from 1.1. 2022.
- Postdoc Katrine Syppli Kohl was employed as a postdoc 24 months in the "Boundary work"-project led by Marie Sandberg, starting from September 1st 2021. Two student assistants, Benno Brudzniki and Maya Dyval have been recruited to the project as well.
- Associate prof. Martin Lemberg Pedersen's H2020 ADMIGOV project was hosted at AMIS from Nov 1st 2020- 31st of June 2021.
- Line Steen Bygballe is writing her PhD at Copenhagen Centre for Health Research in the Humanities (CoRe) and is also be associated with AMIS. Co-supervisor is Marie Sandberg.

AMIS staff meetings are held every Wednesday throughout the year, including internal lectures and brown bag presentations by team members, guest researchers and affiliated researchers from the Faculty of Humanities and UCPH.

2021 has been devoted to be focusing on AMIS research which was also the main theme for the yearly AMIS Internal Seminar, held in June 2021 together with AMIS staff and advisory group.

AMIS organized an external funding workshop, which will be a recurring event along with SAXO research support and HUM research support meetings.

AMIS Research

Over the past years AMIS has attracted and hosted a range of excellent research projects funded by private as well as public foundations such as the Danish Research Council, the Velux Foundations and H2020.

Between 2019-2020 the centre has attracted a total amount of **7.716.532 DKK** external research funding including international postdoc bench fees (see attachment 2) covering the following grantors: VELUX Foundations (HUMpraxis), DFF (FSE Forskningsophold i udlandet), DFF (Sapere Aude, subproject), Vetenskapsrådet (International Postdoc, bench fee), Global Challenge Research Fund (UK), Swiss National Science Foundation: Early Postdoc Mobility (bench fee). As per Feb 2022 a total of 4 externally funded research projects are based at and/or hosted by AMIS:

In 2021 AMIS staff and affiliates applied for an amount of DKK **22.942.540** external research funding, which includes applied funding for ERC.

From 2019-2021 the total grant amount applied for was **56.423.778** DKK.

These figures bear witness to a very high and still rising level of research application activity among AMIS staff and affiliated colleagues.

The centre is in dialogue with HUM research support on future H2020 applications and it is a continued goal to attract MC scholars including MC PhD networks to the centre and to increase the number of PhD students.

The Covid-19 situation has affected several of the research projects at the Centre, especially those committing to fieldwork investigations through 2021. Especially our younger scholars have been facing challenges working from home and missing out on the everyday working environment at AMIS. Throughout the year we have maintained contact and collegial support during weekly online meetings and AMIS events organized online.

Publications and public dissemination

The AMIS group presents itself as a very active research environment with a high publication rate.

Apart from the two editors and a number of contributors there were also presentations by the two discussants: Professor Laura Hammond from SOAS and postdoc Kudakwashe Vanyoro from the University of Witwatersrand.

 AMIS hosted the yearly AMIS-MIM student conference. The theme of the conference was Invisibility and migration research, and the keynote speaker was Jesper Bjarnesen, from Nordic Africa Institute at the University of Uppsala. The conference had presentations by students and young scholars from AMIS and MIM and took place physically UCPH SC while being streamed to our colleagues in Sweden.
- AMIS has started an informal seminar series with Global Refugee Studies at AAU, where we present work in progress and get to know each other's research environments.

Guest scholars and international networks

AMIS attracts a flow of excellent visiting researchers and guest PhD students, and each year the center receives several applications from international postdocs and PhD students as well as tenured staff.

- Peter Eriksson, Malmö University, was a guest PhD researcher.

- Ditte Shapiro, Associate Professor, Center for Social Work at University College Absalon was a guest researcher at AMIS in September and October 2021, as part of the research project 'Boundary work refugees and the state-civil society nexus in a hyper-precarious self-reliance and return regime in Denmark'.
- Martin Joormann completed his PhD in Sociology of Law with his thesis <u>Legitimized Refugees</u> (2019, Lund University). From August 2021 to July 2023, Martin will be a Visiting postdoc AMIS. He is currently conducting research for his VR International Postdoc, which is based at Lund's Sociology of Law Department. This postdoc project is a collective case study of Danish, German and Swedish appeal instances that decide on the review of rejected asylum claims. The study's point of departure is to explore the varying extents to which these appeals are politicized in Denmark, Germany and Sweden.

AMIS continues its connections with several international research networks:

- IMISCOE, the state-of-the-art international network for migration research, represented by Marie Sandberg as a member of the board of directors
- NMR -Nordic Migration Research, the largest research network for Nordic migration scholars, represented in the board by AMIS associate professor Zachary Whyte as vice-chair.
- EuMIGS, Erasmus+, represented by associate professor Simon Turner.
- From 2020 and onwards associate professor Simon Turner is co-editor of *Journal of Refugee Studies*.

Master of Arts in Advanced Migration Studies

The Master of Arts in Advanced Migration Studies is an intrinsic part of the Centre's activities, and a continued strengthening of the integration between research and education is a leitmotif of AMIS enhancing research-based education.

AMIS alumni network *amisan* (established 2019) is very active contributing to a close cooperation between AMIS staff, students, and alumni.

• An AMIS Welcome Pack for new students has been prepared in cooperation with *amisan* strengthening an 'AMIS narrative' depiciting the journey from A-Z in the Master programme.

With the new AMIS curriculum 2022 and the promotion video on AMIS research 2021, the research profile as a center with a strong profile within qualitative and ethnographic migration research has been strengthened.

In sum, AMIS has established itself as a strongly profiled center for migration research at the humanities at UCPH with a very high application rate for externally funded research applications and a solid publication rate.
